Treasurer's Report by Ken Brooks, Sr: Current balance as of March \$2,760.15. Pending income from BWC UMM is \$100.00 and pending disbursement \$320.00 to Richard Campbell for the Evan Young Awards expenses.

Old Business

- Richard reported that the 2019 BWC UMM Annual Prayer Breakfast at Calvary UMC was a
 great success, with 133 paid attendees and 7 guests. After all expenses, in accordance with
 BWC UMM procedures, Calvary UMM will receive \$687.29 of the \$1,374.57 of the net
 profits.
- Richard is preparing an Annapolis District UMM Newsletter (CrossTalk) will include a story about the prayer breakfast and two articles written by James Gainey and Johnny Walker regarding Prayer. Richard also reported that he found an online service, eVoice.com, that allows an administrator (to forward phone calls from the 800 Conference phone line to other phone numbers based on day of week and time of day. This service which costs \$12.95 /month basically emulates the Upper Room Prayer Line Service which is schedule to end April 30, 2019. Richard passed this information along to the Conference Prayer Advocate and BWC UMM President for consideration. Richard suggested that if the Conference is not interest, perhaps the Annapolis District UMM could do a pilot project

with the men and women of the District Churches in combination with the initiative started 3 years ago to post flyers about prayer and a number to call in grocery stores, bars, liquors stores, etc. Discussion about this concept was tabled for a future board meeting.

- Richard reported that he hopes to have the "Generous Disciple" online study that he and Greg Witte will lead ready sometime this summer.
- Richard reported that he hopes Geeks for Jesus ministry will be operational before the end of the year.
- The Annapolis District UMM Trifold should be completed by end of month
- The updates to the DVD PowerPoint presentation about the Annapolis District UMM should be completed by end of the month.

New Business

- Curtis suggested three things the UMMen should do to further its ministry to make disciples for Jesus Christ
 - O Try something new don't stay in the past look to the future
 - o UMMen ministries should unite each other and not be competitive
 - o Communication with each other is essential
- Richard handed out a paper, "7 Conversations to have with your team" (copy attached)
- Richard presented an opportunity for the UMMen of the District to walk to stop hunger in the Anne Arundel County and worldwide, through the upcoming CROP Hunger Walk on Sunday, May 19, 2019 1:00 PM. The walk will start at Glen Burnie UMC, 5 Second Ave., SE, Glen Burnie, MD 21061. Each UMMen walker will receive a specially designed t-shirt (see attachment). The goal is to raise \$1,500 as a team. - UMM West River Work Day is scheduled for Sat., May 18, 2019 8:00 am to 3:00 pm at the West River UMC Retreat Center, 5100 Chalk Point Rd., West River Md 20778. We need 20 men to sign up help repaint and repair sailboats, paddleboats, canoes and kayaks. Volunteers should notify Richard no later that May 12, 2019 so the Camp can order lunch (free to volunteers). The Cluster Phone callers need to get the word out to all churches on their list. - Annapolis District UMM Family Day at Quiet Waters Park, Annapolis
 The Board voted to charge \$25/adult and \$7/children 12 and under. The menu will
 include attendees pre-selecting their entrée: Fried Chicken (2 pieces), Fried White Fish (2
 pieces) or Fried Crab Cake (1) plus baked beans, potato salad, drinks, hots dogs and
 hamburgers and deserts. Richard reported that last year we spent \$1600. Like last year the
 event will include games for all ages. Shelby volunteered his DJ services for the event –
 music mixed genres. Richard will order 150 tickets and distribute them at the West River
 Work Day or mail them to the Board. Maximum. Capacity of the venue is 100. Board
 also agreed to send out post cards to the district churches using the same list that was
